First Semester			
CRI 111	Introduction to Criminology	3.0	This course provides the basic understanding of a theory, its development, and application to the etiology of crime, and its use to understanding human, criminal and deviant behaviors. It includes the historical evolution of criminology, the different school of thoughts, the process of measuring crime, as it relates to criminological research, the divisions and scope of criminology, and the justice system. This course also introduces Criminology as a profession in the Philippines.

CRI 121	Introduction to Philippine Criminal Justice System	3.0	This course explores the study of the five pillars of the criminal justice system in the Philippines – law enforcement, the prosecution, the courts, the corrections, and the community. It also covers their respective functional relationships as well as individual roles in the administration of the justice system in the solution of crimes.

CRI 213	Law Enforcement Organzation and Administration	4.0	This course provides the fundamental understanding of Organization, Management and Administration, laws governing the organization of Law Enforcement and Public Safety Agencies, their respective legal mandate, functions and responsibilities, and its intra and inter agency relations, coordination and cooperation with other law enforcement and public safety agencies
SECOND YEAR

CRI 222	Fundamentals of Investigation and Intelligence	4.0	This course covers the basic principles on relevant Laws, Constitutional Rights, New Rules on Evidence and Criminal Procedure in relation to Investigation. It includes the entire perspective of Intelligence operations and organization, and the different methods of gathering and collecting of Information. The different methods of Extracting Information, the different instruments to aid the investigation, Crime Scene processing, Arrest, Search and Seizure, Cyber Warrant, Wiretapping, the making of investigation reports, Case build up and the preparation of evidence for court presentation.

CRI 211	Theories of Crime Causation	3.0	This course captures the theoretical perspective of crime causation committed by individuals and institutions. It provides a wide array of theories from all dimensions and aspects of the person, the society and the institutions, such as political, economic, environmental, social, psychological, biological, women offenders, biopsychosocial, and life course.
CRI 212	Human Behavior and Victimology	3.0	This course covers the study on human behavior with emphasis on the concept of human development and abnormal behavior. It includes strategies and approaches in handling different kinds of abnormal behavior in relation to law enforcement and criminal proceedings. It also includes the study of victimization, the role of community and techniques in assisting offender's reintegration and victim's recovery.
CRI 214	Comparative Models in Policing	3.0	This course provides an overview of the different Policing System in other countries including its strategies in Crime Prevention and Crime Investigation, and the respect of human rights, personnel qualifications, recruitment, and training. The Philippine extradition treaty with other countries, and the INTERPOL, the international cooperation in the policing of transnational crimes and criminals.
CRI 215	Introduction to Industrial Security Concepts	3.0	This course provides the overview of the following: Development of Security Industry; Theories, Concepts and Principles of security; Security organization, management, administration and operation of private security agency, corporate and government security unit; qualifications, trainings, skills or competencies development in industrial security, technology-led security operations, crime prevention, safety, investigation and detective skills, crime scene preservation, and report writing.

CRI 316a	Technical English 1 (Investigative Report Writing and Presentation	3.0	This course coveras the study of the concept of application of the appropirate report writing, office memorandum and correspondence. The brevity, clarity, comprehensiveness and accuracy of facts and presentation according to the prescribed format and style of investigative report writing structure, correspondence, and memorandum. It includes the fundamentals and styles of different report writings and contents of police report writing, manner of handling standards police forms and technique, and sequence of blotter entries.
CRI 227/L	Forensic Photography	2/1	This course covers the historical development, principles and processes of Photography in relation to law enforcement and criminal justice. This includes the evolution of Camera, photographic processes and personalities behind the development of modern Photography, use of forensic light sources and techniques and related laws and jurisprudence in Photography.
CRI 228	Environmental Laws, Protection and Investigation	3.0	This course covers the environmental laws, the detection of violation, conduct of investigation, evidence required and prosecution, and also the applicable jurisprudence.

CRI 223	Specialized Crime Investigation 1 w/ Legal Medicine	3.0	This course covers the special study of modern technique in the investigation of crimes involving crimes agai persons, and other related offenses. The application of medical science in crime investigation with emphasis medico-legal aspects of physical injuries, death, abortion, infanticide, burn and poisoning. Develop framewo investigating crimes, crime scene processing, and report writing.
CRI 224	Traffic management and Accident Invetigation	3.0	The course covers processes of traffic management, the agencies regulating transportation and the traffic far and control devices. The elements of Traffic Management, Traffic Administration and Traffic Law Enforcement traffic violations, and traffic accident investigation.
CRI 225	Professional conduct and Ethical Standard	3.0	This course deals with the professional conduct and ethical standards of Professionals, and as Criminologists practice of their profession and field of specialization; Governing Ethical codes both in Government and Privasectors and their relevance to Human Relations.
CRI 313	Institutional Corrections	3.0	This course covers the philosophy, theory, and principles of Penology, the institutional relationship to Criminand Criminal Justice. It includes the concept and issues of sentencing, penalty, the administration, and management Institutional confinement facilities of Persons Deprived of Liberty (PDL) such as the Police (PNP, Immigration, others) detention facilities, BJMP, provincial jails, and the Bureau of Corrections.
CRI 221/L	Personal identification Techniques	2/1	The course covers the different methods of personal identification, as an aid to crime detection, investigation information, and as evidence for prosecution of an offense/felony. It includes the processes of recording, processing, preservation, and court presentation.

CRI 311/L	Forensic Chemistry and Toxicology	3/2	This course provides an overview of the major disciplines of forensic chemistry and forensic toxicology, with examples to demonstrate their specific contributions to identification, collection, preservation, investigation, presentation, and biological and chemical analyses of physical evidence for the effective dispensation of justice.

CRI 319a	Character Formation 1-Nationalism and Patriotism	3.0	This course covers the study of principles and Philosophy of nationalism and patriotism, the Philippine Constitution, the Philippine Flag, the Filipino Character, Values, and Culture, including other important Filipino Heritage, History, and Identity as a People and Country.
CRI 300a	Criminological Research 1 (Research Method with Applied Statistics)	3.0	This course focuses on how writing research paper/thesis is done, and the applicable statistical tools, understanding the different parts of the thesis, their interplay, and the governing rules in writing a technical paper, the development of a research problem, the instrument, the data gathering methods, and the treatment of the data collected.
CRI 314	Criminal Law (Book 1)	3.0	The course covers a thorough analysis of elements of crimes under different titles and their amendments and applicability in the administration of justice with an emphasis on recent principles of law, jurisprudence, and special laws while recognizing the fundamental right of a person as provided in the Constitution, Revised Penal Code and other relevant statutes.
CRI 315	Specialized Crime Investigation 2 w/ Simulation on Interrogation and Interview	3.0	This course provides emphasis on the Constitutional Rights of persons arrested, placed under investigation, search, and seizure. It takes on the conduct of interview and interrogation of a suspect, person of Interest, and witnesses and simulates on the different crimes against person economic crimes, and other special laws on transnational and organized crimes. The evidence required and the report writing.
CRI 325	Vice and Drug Education and Control	3.0	This course will talk about the different kinds of human vices and the different kinds of drugs: It will deal on Sociological, Psychological, and Physiological perspectives and dimensions on the effects of drug use and abuse and social development of vices. It will cover the different laws governing, regulating, and prohibiting drugs and vices. The enforcement of these different laws, relevant jurisprudence, the investigation, gathering of evidence, arrest, and seizure of drugs and vices.
CRI 317a	Juvenile Delinquency and Juvenile justice System	3.0	This course will also include dealing with the etiology of delinquency, the theories of delinquency, deviant behaviors and factors that cause it, and the measures for deterrence and control of teenage crime.
CRI 318/L	Questioned Document Examination	2/1	This course covers the basic concepts and principles of questioned documents examination. It particularly gives insight regarding handwriting identification, forgery, and its execution. Typewriting identification, alteration of documents, counterfeiting and the importance or role of a questioned document expert towards the administration of justice, and the care and preservation of evidence for court litigation.

GD1224	Law Enforcement Operation and Planning w/	3.0	This course provides the fundamental concepts of planning as a leadership role and the operations of selected Law Enforcement and Public Safety Agencies and their respective legal mandates and limitations under existing laws.
CRI 321	Crime Mapping International Terrorism	3.0	The Crime Mapping and its relations to police operations. This course examines the goals, strategies and actions of international terrorist groups, the efforts of governments to combat terrorism, and the effect of international terrorism on contemporary international relations. Special attention is given to philosophies of violence and to ethical issues surrounding terrorist and counter-terrorist actions
CRI 301a	Criminological Research 2 (Thesis Writing and Presentation)	3.0	This course is intended to equip the students with the necessary knowledge and understanding of the basic concepts and principles of research. It explores the different ways in which Criminological Research is carried out. It includes the different styles of Criminological research (e.g. case study, policy-related, action-based), different types of research, and the use of statistics.
CRI 323	Criminal Law (Book 2)	4.0	The course covers a thorough analysis on elements of crimes under different titles and their amendments and applicability in the administration of justice with an emphasis on recent principles of law, jurisprudence, and special laws while recognizing the fundamentals rights of a person as provided in the constitution, Revised Penal Code and other relevant statutes.
CRI 324	Fire Preotection and Arson Investigation	3.0	The course presents the creation of the Bureau of Fire Protection, its mandate, powers, and functions. It also covers the understanding of the behavior, characteristics, and chemistry of fire. It involved fire safety and protection, including the conduct of arson investigation.
CRI 330	Character Formation 2: Leadership Management, Decision making, Management Administration	3.0	The course covers the understanding of personal values, characteristics, and goals including the normative foundations of leading which includes the wide array of leadership and management approaches and refine their leadership and management styles. Understand the frames of judgment and skills needed to affect positive change in a wide array of settings and to transform cultures, organizations, and institutions through effective leading, management, analysis, and decision-making in a self-aware manner to think and act strategically.
CRI 322	Dispute Resolution and Crises/Incidents Management	3.0	This course deals with the study of the different mechanisms in dealing and resolving conflicts/disputes. It includes the art of intervention through mediation, and reconciliation between stakeholders and agencies tasked to carry out the endeavor. Likewise, the course includes the concepts of crisis management and the proper procedure in handling the incident. Moreover, the study significantly provides mechanisms on how to adopt strategies in dealing with potential and actual crises which are being addressed by concerned agencies and authorities and the community.

CRI 328/L	Lie Detection Techniques	3.0	This course includes the study of the different methods and techniques in lie detection. The anatomy of lying, its theory, kinds and types. It includes the conduct of polygraph examination. It also covers the history, personalities and developments of Lie detection in different countries as a tool of crime investigation and also in relation to cour proceedings.

CRI 416	Therapeutic Modalities	2.0	This course covers the different therapeutic modalities, treatment models, treatment programs, and policy or program intervention for both in institutional and non-institutional corrections. The forging of partnerships, involvement, and engagement of government agencies, religious sector, Private foundations, institutions, and non-governmental organizations focused on the detainee's/Inmate's/person Deprived of Liberty's total welfare well-being.

It includes the Rules on DNA Evidence, Rules electronic Evidence, Rules on Child witness Examination, Rights of Witnesses and other relevant issuance of the Supreme Court or other authority, and applicable relevant jurisprudence.

			This course is intended to develop an understanding and exposure into the psychology and sociology of crimes, crime detection and investigation and criminalistics, actual operations of a police station/department, jail or penal institution, fire department and security agencies and such other agencies comprising the five(5) pillars of the criminal justice system and the relationship between them as a supplement and a conjunction with the academic program in selected police agencies; actual fieldwork, observation and practice of police tasks, activities or operations, including patrol, traffic, crime investigation, criminalistics, performed internships requiring observations in penal institution, jail, reformatories in NBI,PDEA,CRIMELAB,BFP and chosen barangays and such other agencies related to the course/program. This course is also aimed at providing students with an opportunity to understand the economic, social, and cultural reality of the community. It is centered on students getting in touch with themselves as they interact and relate with individuals, groups and families in selected nearby community. The course is divided into three phases namely: Pre-immersion phase, immersion phase, and the post immersion phase.
